ORDINANCE NO. 3- 2015  
AMENDING CHAPTER 66 – TRAFFIC AND VEHICLES

The Ann Arbor Charter Township Board of Trustees ordains and adopts the following additions to Article II of Chapter 66 of the Township Code of Ordinances as follows:

**DIVISION 3 – Gabriel Richard High School [ALL NEW]**

**Sec. 66-59. – Definitions**

The following words, terms and phrases, when used in this division, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

*Motor vehicle* means every vehicle which is self-propelled.

*Motorcycle* means every motor vehicle having a saddle or seat for the use of the rider and designed to travel on not more than three wheels in contact with the ground, but excludes a tractor.

*Motor-driven cycle* means every motorcycle, including every scooter with a motor which produces no more than five maximum brake horsepower, and every bicycle with motor attached.

*Parking* means standing a vehicle, whether occupied or not, upon a place provided for parking and designated as a place for parking, except that vehicles loading or unloading or making necessary repairs shall not be deemed to be parking.

*Police officer* means every sheriff, or sheriff's deputy; the state police or other law enforcement officer designated by the Township Board.

*Gabriel Richard High School campus* includes all property in the Township owned by the Diocese of Lansing or its successor and used for high school purposes, including those areas commonly known as Tax Parcel No. I-09-13-200-020.

**Sec. 66-60. - Unlawful acts.**

(a) *Parking in fire lane.* It shall be unlawful for any person to park or cause to be stationary, occupied or unoccupied, a motor vehicle, motorcycle, or motor-driven cycle in any designated fire lane on the Gabriel Richard High School campus. A fire lane must be designated as such by signs posted periodically along the fire lane route.

(b) *Parking in no parking area.* On the Gabriel Richard High School campus it shall be unlawful for any person to park, or cause to be stationary, occupied or unoccupied, any motor vehicle, motorcycle or motor-driven cycle in any area designated as a no parking area. A no parking area must be designated by a sign or painting on the pavement or within the parking area, that says in appropriate words or indicates by lines that there is no parking within that specific area.

(c) *Parking within pavement markings.* Where there are specified parking areas designated by lines or other instruments painted upon the pavement or other surface, or by signs displaying specified parking areas, it shall be unlawful for any person on the Gabriel Richard High School campus to park, or cause to be stationary, occupied or unoccupied, any motor vehicle, motorcycle or motor-driven cycle, unless it is parked or stationary completely within the aforementioned pavement markings which may exist.

(d) *Parking on sidewalks, etc.; blocking entrances.* On the Gabriel Richard High School campus, parking on a sidewalk, in front of a driveway or service entrance, on a clearly marked crosswalk, in a clearly marked bus stop, or in any place or manner so as to block entrance or exit to a building shall be unlawful.

(e) *Time limit.* No person shall park a motor vehicle on the Gabriel Richard High School campus for more than 72 continuous hours.

(f) *Parking in restricted area.* In any restricted parking area on the Gabriel Richard High School campus designated as "tow-away zones," vehicles parked in violation of the restrictions may be towed away and impounded. The reasonable cost of removal and storage shall be borne by the owner of the vehicle.

**Sec. 66-61. - Enforcement of division.**

(a) Enforcement of any part of this division may be executed by any of the Washtenaw County Sheriff's Department deputies, Ann Arbor Charter Township Fire Department personnel, and other designated Township enforcement officers or personnel.

(b) For violation of this division, the registration plate attached to such motor vehicles shall constitute, in evidence, a prima facie presumption that the owner of such motor vehicle was the person who parked or placed such motor vehicle at the point where such violation occurred.
