**From Section 74-61 (g) Sign requirement.** For proposed amendments to the zoning map, the applicant or owner of the property shall place a sign no less than four feet by four feet on each side of the affected property that abuts a street. The sign shall not be erected in the road right-of-way or in a manner that would obstruct the vision of motorists or pedestrians. Each sign shall be erected at least 21 days, but not more than 30 days, before the Township public hearing on the application, and shall remain in place through the date of the public hearing. Each sign shall be removed from the property no later than three business days following the public hearing or the adjourned or continued date of the public hearing, whichever is later. Each sign shall state in six inch letters "PROPERTY PROPOSED FOR REZONING" and shall state in letters of no less than two inches the street address or tax code parcel number, acreage of the property, the current zoning and proposed zoning and the date, time and place of the public hearing.
