Ann Arbor Township Code of Ordinances

Sec. 46-1. Permit.

(a) No person shall peddle or solicit goods, services, or contributions door to door without a permit issued by the Township Clerk. Such a permit shall be issued upon filing of an application with the Township Clerk, payment to the Township Clerk of a fee in the amount established by resolution of the Township Board, and a finding by the Township Clerk that the applicant is of good moral character.

(b) Such permits shall be issued for a maximum term of ten days.

(c) In this section, the phrase "good moral character" shall be construed to mean the propensity of the person to serve the public in the licensed area in a fair, honest, and open manner. A judgment of guilt in a criminal prosecution or a judgment in a civil action shall not be used in and of itself as proof of a person's lack of good moral character. It may be used as evidence in the determination and when so used the person shall be notified and shall be permitted to rebut the evidence by showing that:

(1) At the current time the person has the ability to and is likely to serve the public in a fair, honest and open manner; and

(2) The person is rehabilitated, or that the substance of the former offense is not reasonably related to the activity for which such person seeks a permit.

(d) The following criminal records shall not be used, examined, or requested by the Township in a determination of good moral character when used as a requirement to obtain a business license or business permit:

(1) Records of an arrest not followed by a conviction.

(2) Records of a conviction which has been reversed or vacated, including the arrest records relevant to that conviction.

(3) Records of an arrest or conviction for a misdemeanor or a felony unrelated to the person's likelihood to serve the public in a fair, honest, and open manner.

(4) Records of an arrest or conviction for a misdemeanor for the conviction of which a person may not be incarcerated in a jail or prison. State law references: Moral character, MCL 338.41 et seq.

Sec. 46-2. Hours of operation.

No person shall perform any act for which a permit is required by this chapter except between the hours of 8:00 a.m. and 9:00 p.m.
